## These photos memorialize the first ride 1997



**In 1997, Penn State Children's Hospital in Hershey, Pennsylvania was looking for help.**

**The Child Life Department requested toys and other items to support their programs.**

**The York County Harley Davidson Owners Assoc. Inc.\* answered their plea.**

It wasn't a hard decision to make. Sick kids should have something to take their minds off the daily ordeal they must face. We found that local hospitals send the most seriously ill children to Penn State Children's Hospital in Hershey so it made sense to take the toys where they were most needed. Our first toy run was held on a cold, rainy November day in 1997. We only had 12 riders and a handful of toys, but it was a start. Through the generosity of sponsors, such as you, we have provided over \$300,000 dollars worth of toys and requested items in support of the hospital and the Children's Miracle Network. We hope to continue this level of support.

Our ride is named "The David Milliken Derr Jr. Memorial Toy Run" in remembrance of a dear little boy we fell in love with on our first visit. David had his picture taken on a motorcycle and later followed us around, pulling his IV stand, as we toured the children's ward. David suffered from a brain tumor and fought valiantly to overcome his illness. He lost his battle three days before Christmas, 1997, at the age of seven. His bravery and courage will not be forgotten. His memory stands as a reminder of the struggle no one should have to endure. If we can bring a little joy, raise a smile, or comfort one other child like David, then we will continue to ride to the Children's Hospital in Hershey.
